ARTICLE I
General Provisions

§ 140-1. Definitions.

- A. The words and phrases used in this chapter shall for the purpose of this chapter have the meanings respectively ascribed to them by Article I of the Vehicle and Traffic Law of the State of New York.
- B. The following words and phrases which are not defined by Article I of the Vehicle and Traffic Law of the State of New York shall have the meanings respectively ascribed to them in this section for purposes of this chapter.

CURBLINE — The prolongation of the lateral line of a curb or, in the absence of a curb, the lateral boundary line of the roadway.

HOLIDAYS — Includes New Year's Day, Lincoln's Birthday, Washington's Birthday, Memorial Day, Independence Day, Labor Day, Columbus Day, Veteran's Day, Thanksgiving Day, Christmas Day and such other days designated as public holidays as provided in § 24 of the General Construction Law.

OFFICIAL TIME STANDARD — The time standard which is in current use in this state whenever certain hours are named herein or on traffic control devices.

PUBLIC PARKING LOT — A plot or parcel of land or building owned and/or leased by this Village, not including highways, upon or within which the parking of vehicles is regulated by signs and/or parking meters.

§ 140-2. Authority to install traffic control devices.

The Superintendent of Public Works shall install and maintain traffic control devices when and as required under the provisions of this chapter, and shall install and maintain such additional traffic control devices as the Mayor or he may deem necessary to regulate, warn or guide traffic under the Vehicle and Traffic Law of the State of New York subject to the provisions of §§ 1682 and 1684 of that law. (The Village has no traffic control signals installed or operated by the Village. However, NYSDOT has installed and operates one traffic control signal at the intersection of Main Street with Mexico Street and Miner Avenue.)¹

ARTICLE II
Stop and Yield Intersections

§ 140-3. Stop intersections.

The following intersections are hereby designated as stop intersections, and stop signs shall be erected on entrances thereto as indicated:

§ 140-4. Four-way stop intersections.

ARTICLE III
Speed Regulations

§ 140-7. Maximum speed limits.³

Thirty miles per hour is hereby established as the maximum speed at which vehicles may proceed on or along highways within the corporate limits of this Village, except as otherwise provided in § 140-8.

§ 140-8. Maximum speed limits in Forest Park. [Amended 5-17-1982 by L.L. No. 2-1982]

Ten miles per hour is hereby established as the maximum speed at which vehicles may proceed on or along roadways within Forest Park.

ARTICLE IV
Parking, Standing and Stopping

§ 140-9. Application of article.

The provisions of this article shall apply except when it is necessary to stop a vehicle to avoid conflict with other traffic or in compliance with the directions of a police officer or official traffic control device.

§ 140-10. All-night parking.

The parking of vehicles is hereby prohibited on all public highways within this Village between the hours of 2:00 a.m. and 6:00 a.m. ←

§ 140-11. Parking prohibited in designated locations. [Amended 9-19-1977 by L.L. No. 2-1977; 11-18-1985 by L.L. No. 5-1985; 12-21-1987 by L.L. No. 2-1987; 2-7-1993 by L.L. No. 2-1993; 2-4-1997 by L.L. No. 1-1997]

§ 140-12. Time-limited parking.

- A. The parking of vehicles is hereby prohibited in any of the following locations between 6:00 a.m. and 2:00 a.m. for a period of longer than two hours:

§ 140-13. Stopping, standing and parking prohibited. [Added 12-7-1999 by L.L. No. 4-1999; amended 12-18-2001 by L.L. No. 5-2001]

Except when necessary to avoid conflict with other traffic or when in compliance with law or the directions of the police officer or official traffic control device, no person shall stop, stand or park a vehicle:

- A. On a sidewalk.
- B. On a crosswalk.
- C. Blocking a private driveway.

- D. Blocking an alley.
- E. Alongside or opposite any street, excavation or obstruction when stopping, standing or parking would obstruct traffic.
- F. Upon any bridge.
- G. With the left side of the vehicle by the curb (parked in wrong direction).

§ 140-14. Overnight parking in designated areas in Village parking lots. [Added 12-3-1979 by L.L. No. 2-1979; amended 3-18-1985 by L.L. No. 3-1985]

The parking of vehicles overnight shall be permitted on an alternate night basis, as determined by the Chief of the Village of Camden Police Department, in those areas within the Village of

Camden's parking lots designated as "Overnight Parking" on Schedule A adopted by the Village Board and certified by the Village Clerk, which accompanies and which, with all explanatory matter thereon, is hereby made a part of this chapter.⁴

§ 140-15. Parking prohibited in Village lots during certain hours. [Added 12-3-1979 by L.L. No. 2-1979; amended 3-18-1985 by L.L. No. 3-1985; 12-7-1999 by L.L. No. 4-1999]

The parking of vehicles in any Village parking lot owned or operated in whole or in part by the Village of Camden, New York, between the dates of November 1 and April 31 and between the hours of 3:00 a.m. and 6:00 a.m. is prohibited except in those areas specified in § 140-14 above. 20

§ 140-16. Restricted stopping, standing and/or parking. [Added 2-7-1993 by L.L. No. 2-1993]

- A. Stopping, standing and/or parking is hereby restricted in the following areas to those vehicles registered pursuant to § 404-a of the Vehicle and Traffic Law or those possessing a special vehicle identification parking permit issued in accordance with § 1203-a of said Vehicle and Traffic Law:

 - (2) That parking lot located on the south side of Mexico Street, adjacent to Fish Creek.

 - (4) That parking lot located on the west side of Main Street between the Episcopal Church and the United States Post Office.
 - (5) That parking lot located on the south side of Church Street between Second Street and Third Street.
- C. Standing in the following areas is hereby prohibited in any of the following locations between 6:00 a.m. and 6:00 p.m. while the Camden Middle School is in session. School buses shall be exempt as long as they are standing to load or discharge students. [Added 9-19-2002 by L.L. No. 3-2002]

**ARTICLE V
Miscellaneous Provisions ⁶**

§ 140-18. Removal and storage of vehicles. [Amended 3-18-1985 by L.L. No. 3-1985]

- A. When any vehicle is parked or abandoned on any highway within this Village or within any parking lot owned or operated in whole or in part by the Village of Camden during a snowstorm, flood, fire or other public emergency which affects that portion of the public highway within this Village or within any parking lot owned or operated in whole or in part by the Village of Camden upon which said vehicle is parked or abandoned, said vehicle may be removed by the authority of the Village of Camden Police Department.
- B. When any vehicle is found unattended on any highway within this Village or within any parking lot owned or operated in whole or in part by the Village of Camden where said vehicle constitutes an obstruction to traffic, said vehicle may be removed by authority of the Village of Camden Police Department.
- C. When any vehicle is parked or abandoned on any highway within this Village or within any parking lot owned or operated in whole or in part by the Village of Camden where stopping, standing or parking is prohibited, said vehicle may be removed by authority of the Village of Camden Police Department.

§ 140-19. Storage and charges. [Amended 3-18-1985 by L.L. No. 3-1985]

After removal of any vehicle as provided in this article, the Village of Camden Police Department may store such vehicle in a suitable place at the expense of the owner. Such

owner, or person in charge of the vehicle, may redeem the same upon payment to the Village Clerk of the amount of all expenses, actually and necessarily incurred in effecting such removal, together with any charges for storage, said amount to be as set from time to time by resolution of the Board of Trustees.

§ 140-20. Notice of removal. [Amended 3-18-1985 by L.L. No. 3-1985]

It shall be the duty of such Police Department to ascertain to the extent possible the owner of the vehicle or person having charge of the same and to notify him of the removal and disposition of such vehicle and of the amount which will be required to redeem the same.

§ 140-20.1. Weight limits. [Added 9-4-2001 by L.L. No. 2-2001]

No vehicles in excess of five tons shall be allowed in R-60, R-75, R-100 and R-M Districts as defined in the Village Code, Chapter 150, except for local pickup and deliveries, maintenance and emergency vehicles.

§ 140-20.2. Boot or locking device. [Added 3-10-2020 by L.L. No. 1-2020]

In addition to any other municipal remedies provided in this chapter for illegally parked vehicles, the Camden Village Police Department is authorized to install a "boot" or locking device on the wheel or wheels of an offending vehicle, and may assess the reasonable fee of installing and removing such "boot" or locking device against the vehicle owner, in addition to the unpaid parking tickets and other assessable fees.

ARTICLE VI

Penalties

§ 140-21. Penalties for offenses. [Amended 12-3-1979 by L.L. No. 2-1979; 2-7-1993 by L.L. No. 2-1993; 11-7-1994 by L.L. No. 3-1994; 12-7-1999 by L.L. No. 4-1999]

- A. Unless provided elsewhere specifically in this chapter, every person convicted of a traffic infraction for a violation of any provision of this chapter which is not a violation of any provision of the Vehicle and Traffic Law of the State of New York shall, for a first conviction thereof, be punished by a fine of not more than \$100 or by imprisonment for not more than 15 days, or by both such fine and imprisonment; for a second such conviction within 18 months thereafter, such person shall be punished by a fine of not more than \$200 or by imprisonment for not more than 45 days, or by both such fine and imprisonment; upon a third or subsequent conviction within 18 months after the first conviction, such person shall be punished by a fine of not more than \$300 or by imprisonment for not more than 90 days, or by both such fine and imprisonment.
- B. Civil penalties. [Amended 12-18-2001 by L.L. No. 5-2001]
 - (1) Notice on vehicle. Whenever any motor vehicle without a driver is found parked or stopped in violation of any of the restrictions imposed by ordinance of this Village or by state law, the officer finding the vehicle shall take its registration

number and may take any other information displayed on the vehicle which may identify its user and shall conspicuously affix to the vehicle a notice, in writing, on a form provided by the Village Police Department, for the driver to answer to the charge against the driver within 48 hours to the Town Justice at and by means specified on the notice.

- (2) Failure of violator to appear; notice to owner. If the violator does not appear in response to the notice affixed to the motor vehicle within the forty-eight-hour period, the court shall cause to be sent to the owner of the motor vehicle to which the notice was affixed a letter or a citation informing the owner of the violation and warning the owner that the owner will be held responsible for the appearance of the offender. If the owner or violator does not respond to the letter or citation of warning within 10 days, the Police Department shall have a complaint entered against the owner or violator and secure the issuance of a warrant or criminal summons for the arrest of the owner or violator.
- (3) Presumption as to violation. In any prosecution charging a violation of any law or regulation governing the standing or parking of a vehicle, proof that the particular vehicle described in the complaint was parked in violation of any standing or parking law or regulation, together with proof that the defendant named in the complaint was at the time of the parking the registered owner of the vehicle, shall constitute in evidence a prima facie presumption that the registered owner of the vehicle was the person who parked or placed the vehicle at the point where and for the time during which the violation occurred. This presumption shall apply only when the procedure as prescribed in this section has been followed.
- (4) Civil penalty. Any violator who shall receive a notice of violation of any of the following traffic violation: parking on a sidewalk, within 20 feet of a crosswalk, within an intersection, within 15 feet of a fire hydrant, in front of a driveway, with left side to the curb or where parking or standing is prohibited or otherwise illegally parked may pay to the Justice of the Town of Camden a civil penalty in the sum of \$25 for and in full satisfaction of such violation if paid within 48 hours.

§ 141-1. Intent.

It is the intent of the Board of Trustees of the Village of Camden to relieve the Town of Camden Justice Court of the administrative problems resulting from the collection of fines for parking violation offenses committed within the Village of Camden and to permit said Justice Court to devote its time to traffic offenses other than parking violations and to other matters.

§ 141-2. Authorization to establish Bureau.

The Justice Court of the Town of Camden is hereby authorized to establish a Parking Violations Bureau and to designate the Village Treasurer as the head of such Bureau, which Village Treasurer is authorized to appoint one or more other Village officials to assist in the administration of the duties hereunder and herein provided.

§ 141-3. Powers and duties.

- A. The Bureau so established shall be authorized to dispose of parking violations only and to collect the fines designated by the Court as penalties for parking violations over which the Bureau has jurisdiction.
- B. Notwithstanding any provision herein, such Bureau shall not be authorized to deprive a person from his/her right to counsel or from his/her exercising his/her right to appear in Town of Camden Justice Court.

§ 141-4. Persons not permitted to appear before Bureau.

Notwithstanding any other provision herein, any person who shall have been, within the preceding 12 months, guilty of more than six parking violations shall not be permitted to appear

in answer to a subsequent violation at the Parking Violations Bureau but must appear in the Town Justice Court at a time specified by the Bureau.

§ 141-5. Interpretation.

Any ambiguity with respect to any provision herein or interpretation hereof shall be governed by Article 14-B of the General Municipal Law, as amended.
