July 9, 2024

A regular meeting of the Village Board began at 5:30 p.m. in the Village Office. Present were Mayor Jeffrey Oatman, Deputy Mayor Jeffery Kelley, Trustees: Erin LaPlante and Todd Scoville. Also, present were Superintendent of Public Works John Heller, Village Clerk Lynnette Carver, Chief of Police Redden, Officers: Muha, Tuff, & Barone, NOCCOG representative John Healt, Fire Dept. President Phil Denison, Kevin Brady, Heather Archibee, Ken Light, Queen Central News Publisher Doug Cleveland.

A motion was made by Trustee Kelley to approve the minutes from the prior meetings. The motion was seconded by Trustee LaPlante and carried unanimously.

Public Comment was held.

Chief Redden reviewed the police report with the Board. It is kept on file at the Police Dept.

Officer Barone was briefly introduced to the Village Board.

A ceremony for promotion of Officer Dan Muha was held. The Village is pleased to promote Officer Muha to Corporal Muha.

NOCCOG representative John Healt reviewed the NOCCOG monthly newsletter with the Board, highlights included:

Quotes for the Village wide insurance coverage were discussed. Trustee Kelley noted that Eastern Shore has provided the Village with good coverage in the past and was very helpful with the recent fire. Therefore, Trustee Kelley made the motion to approve the request for proposal from Eastern Shore. This proposal does not include coverage of the new DPW building; as it is not complete. Mayor Oatman seconded the motion and it carried unanimously.

The Mayor reminded the Board and the department heads that any matter discussed in executive session is not to be discussed outside of executive session.

Resolution #6 of 2024/25

Titled: Teamsters Agreement

A motion was made by Trustee LaPlante to ratify the Labor Agreement by and between the Village of Camden, The Village of Camden Police Department and the Teamsters Local Union 1149. The term of the contract is June 1,2024 (retro) until May 31, 2028. Trustee Kelley seconded the motion and it carried unanimously.

Clerk Carver presented the 1st payroll register of July for the Board's review. A motion was made by Trustee LaPlante to execute approval of the submitted register. The motion was seconded by Mayor Oatman and carried unanimously.

Copies of the Treasurer's report & Capital Projects budget to actual report were submitted for the Board's review and approval. A motion was made by Trustee Kelley to approve the reports as submitted. The motion was seconded by Trustee LaPlante and carried unanimously.

The June bank reconciliations were submitted for the Board's review and execution. A motion was made by Trustee Kelley to approve the statements as submitted. The motion was seconded by Trustee LaPlante and carried unanimously.

A motion was made by Trustee LaPlante to pay all audited bills on Abstract #2 in the amount of \$181,260.91; inclusive of capital project payments totaling \$156,200.93. The motion was seconded by Trustee Scoville and carried unanimously.

As there was no further business to discuss, a motion to adjourn at 7:26 p.m. was made by Trustee Scoville. The motion was seconded by Trustee LaPlante and carried unanimously.
